

## Notice to Mariners

Subject: Fugro Synergy drilling operations in Dogger Bank Wind Farm area in October 2020

Please be advised that Fugro will be performing geotechnical drilling on behalf of Dogger Bank Wind Farm. Vessel Fugro Synergy will work within estimated period from 1 to 14 October 2020. The work will be performed between 150 and 200km to the east off the coast of Yorkshire in Dogger Bank B zone (formerly known as Creyke Beck B).



Fugro Synergy will be deploying downhole equipment which will require to remain stationary for periods up to 24 hours at a time. It is requested that all vessels operating within this area keep at a safe distance of 500 metres and pass at minimum speed to reduce vessel wash. Furthermore, it is requested that anybody having knowledge of any potential objects submerged or moored on the seabed, within the survey area, that could be damaged or form a hazard to the survey vessel and its equipment advises Fugro of their position and nature.
