Notice of Completion of Pre-Construction Geophysical Surveys in 2020 – Issued 29/12/2020

1. INTRODUCTION


Mariners are advised that Hornsea Project Two have completed pre-construction geophysical surveys along the export cable corridor in 2020 for the proposed Hornsea Project Two Offshore Wind Farm. Construction geophysical surveys will continue intermittently across the Hornsea Project Two wind farm area in 2021, the details of which will be covered under a separate existing Notice to Mariners along with ongoing construction activities across the site (Document Reference: 06239336). Please therefore consider this specific Notice closed.

2. AREA OF OPERATIONS

Activities were undertaken on the Hornsea Project Two offshore wind farm proposed export cable route and proposed anchoring locations as shown in Figure 1. The coordinates of the surveyed areas are also provided in Figure 1.











3. SURVEY

3.1 Geophysical Survey

Please be advised that Ørsted have completed pre-construction geophysical surveys using the Titan Endeavour within the Hornsea Project Two export cable corridor and anchor locations for 2020. Further vessels may be mobilising in early 2021 to support ongoing construction activities for the Hornsea Two Wind Farm. These vessels and activities are captured by a separate Notice to Mariners which is updated as required (Document Reference: 06239336).
