

Notice to Mariners – Hornsea Project Two

Notice of Intertidal Works Update – Demobilisation of Beach Equipment - 16/07/2021

1. INTRODUCTION

Mariners are advised that Ørsted have demobilised the export cable installation equipment from the beach and have buried all three export cables within the intertidal area. The export cable seaward of Mean Low Water Springs requires further burial works to be undertaken in the coming weeks therefore mariners should take note of this area. Further beach reinstatement is ongoing.

2. AREA OF OPERATIONS




Figure 1. Beachworks Area

Activities within the beach area for the Hornsea Project Two Offshore Wind Farm (intertidal area) as shown in Figure 1 are nearly complete. Mariners are advised that MaxSea and Olex plotter files of the proposed works area can be provided by the Project's Commercial Fisheries Advisors at Brown and May Marine Limited and the Project's onshore fisheries liaison. Contact details are provided in Section 5 of this Notice.

3. COMPLETED AND ONGOING ACTIVITIES

3.1 Landfall Cable Installation

The final export cable pull-in has been completed at the beach landfall and the cable has been buried between Mean High Water Springs (MHWS) and Mean Low Water Springs (MLWS). Equipment supporting cable installation has been removed from the beach, including the Maagd barge, however reinstatement work is ongoing on the beach. The export cable seaward of MLWS requires further burial therefore Mariners should take note of this area. Export cable installation and burial seaward of MLWS will be ongoing until end of 2021.

3.2 Safety

It is requested that anybody having knowledge of any potential objects submerged or moored on the seabed within the works area that could be damaged or form a hazard to the vessels and their equipment advises the Project's Fishing Industry Liaison of their position and nature.
