## Notice of Geophysical Survey Commencement

### 1 Introduction

Mariners are advised that Orsted Hornsea Three will be commencing a scope of geophysical survey works from 29/11/2021 at the sites listed below:

- Sizewell

The survey is being undertaken for the purposes of geophysical investigations of proposed Kittiwake tower nesting structures as part of a compensation scheme associated to the Hornsea Project Three Offshore Wind Farm (Hornsea Three) project, located within the UK Sector of the North Sea.

### 2 Area of operations

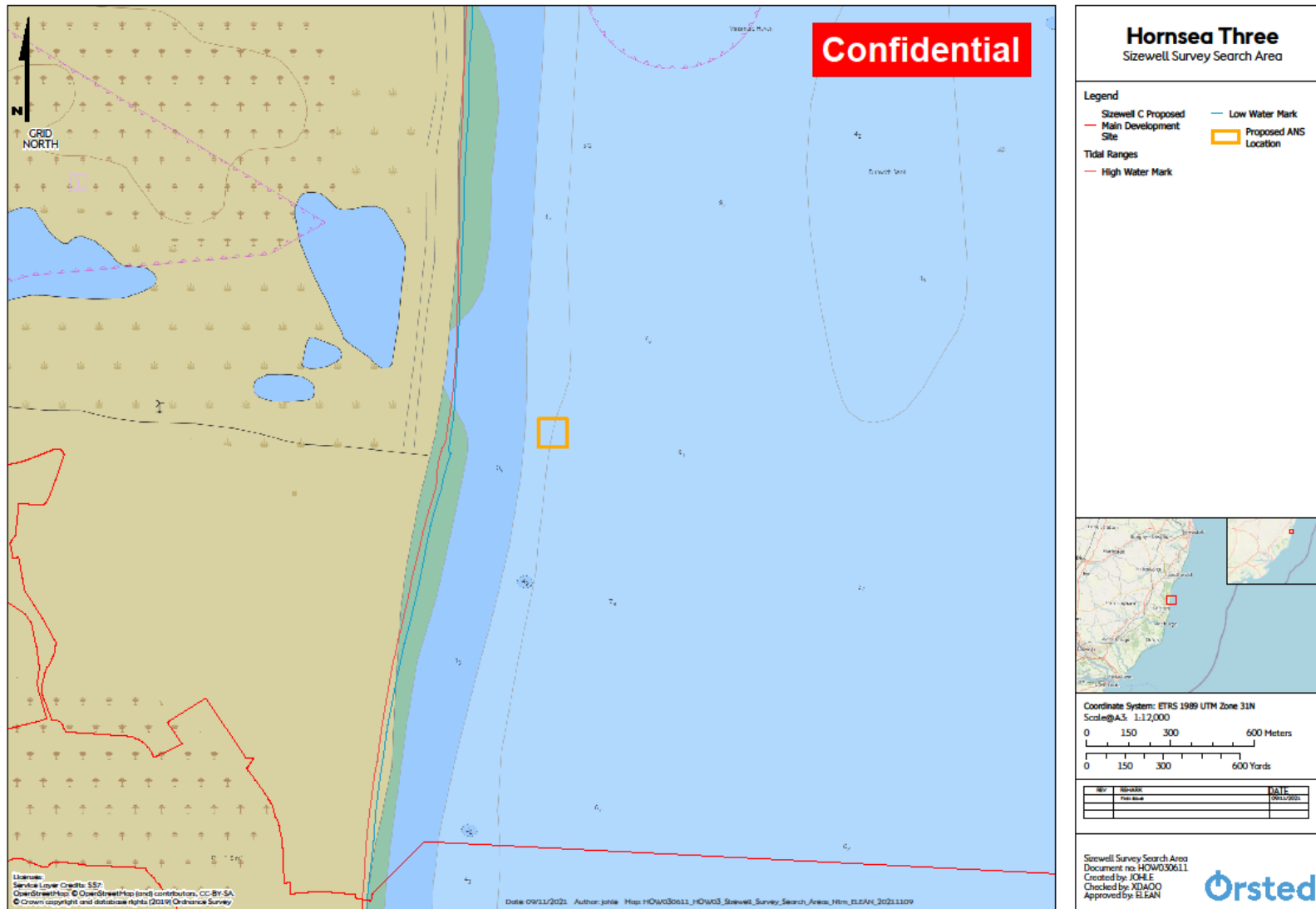


Figure 1. Hornsea Three Survey Coverage – Sizewell

The extent of the area in which the survey will be conducted is shown in Figure 1.

### 3 Proposed activities

#### 3.1 Proposed survey activity

Please be advised that the operations are anticipated to mobilise from Lowestoft with investigations targeting the site. The works will last for approximately 21 days, allowing for mobilisation, demobilisation and weather contingency. Site specific works will last for approximately 5 days within the 21 day window. The exact survey dates are dependent on mobilisation time, weather and work progress.

Note that the vessels will have limited manoeuvrability and it is requested that all vessels operating near the survey vessels maintain a safe distance (at least 500m) and pass at minimum speed.

#### 3.2 Safety

It is requested that anybody having knowledge of any potential objects submerged or moored on the seabed within the survey area that could be damaged or form a hazard to the survey vessel and its equipment advises Hornsea Three’s Onshore Fisheries Liaison of their position and nature.
