1. Introduction

RWE Renewables has contracted Fugro GB Marine Limited (Fugro) to carry out a geophysical and environmental site investigation in the North Sea for the proposed Dogger Bank South Offshore Wind Farms (DBS) array site and export cable routes.

The Dogger Bank South Offshore Wind Farms array site is located 70 Nm East of Flamborough Head on the southern edge of Dogger Bank, with export cable route options extending to a beach landing in the vicinity of Bridlington.

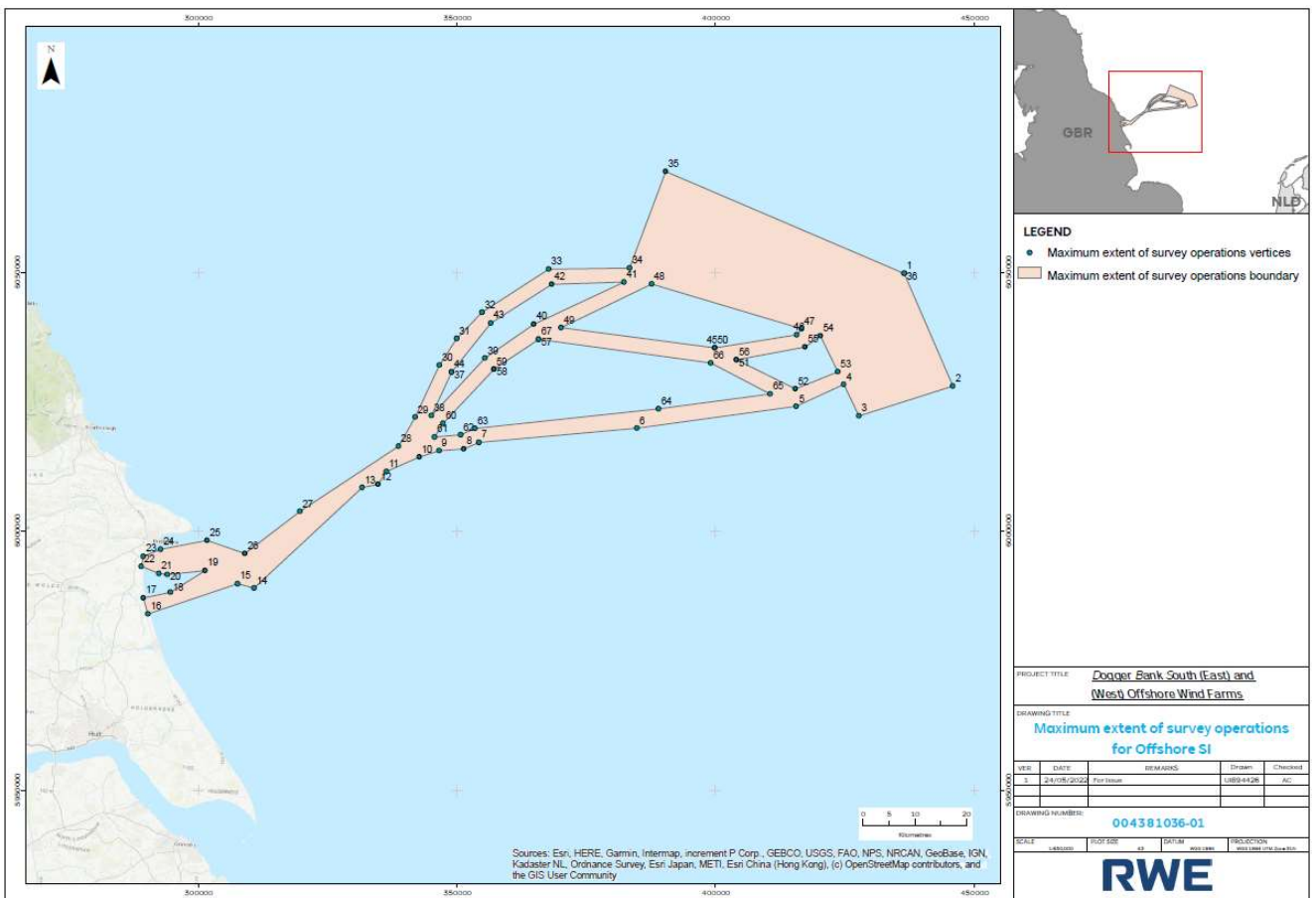


Figure 1.1 Dogger Bank South maximum extent of survey operations

The maximum extent of survey operations is presented in Figure 1.1.

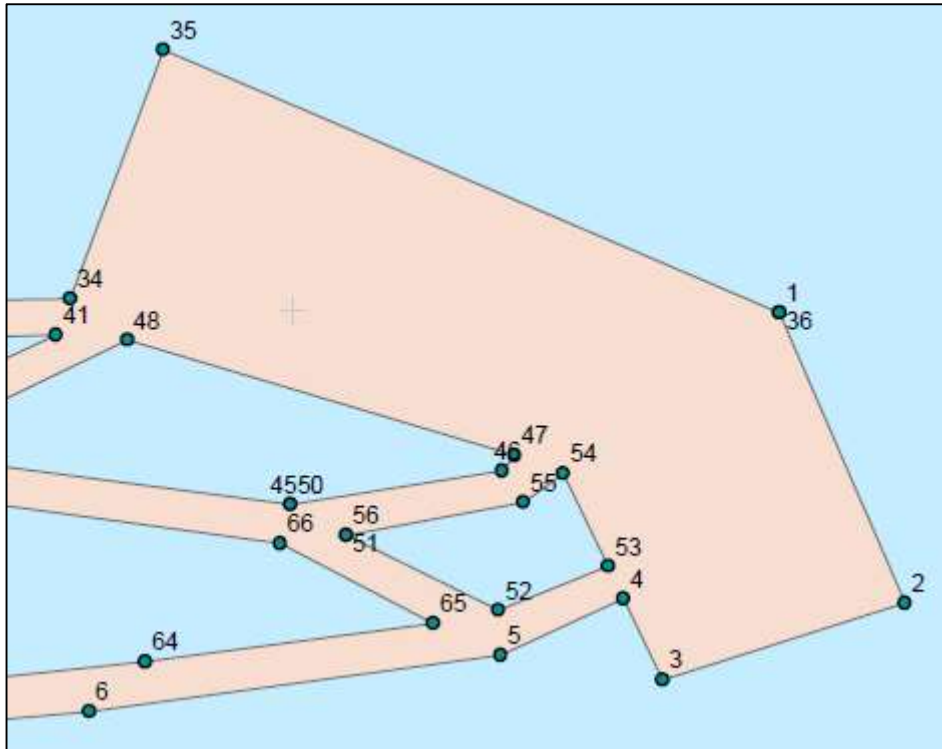


Figure 2.1 Maximum extent of survey operations (Array Area)

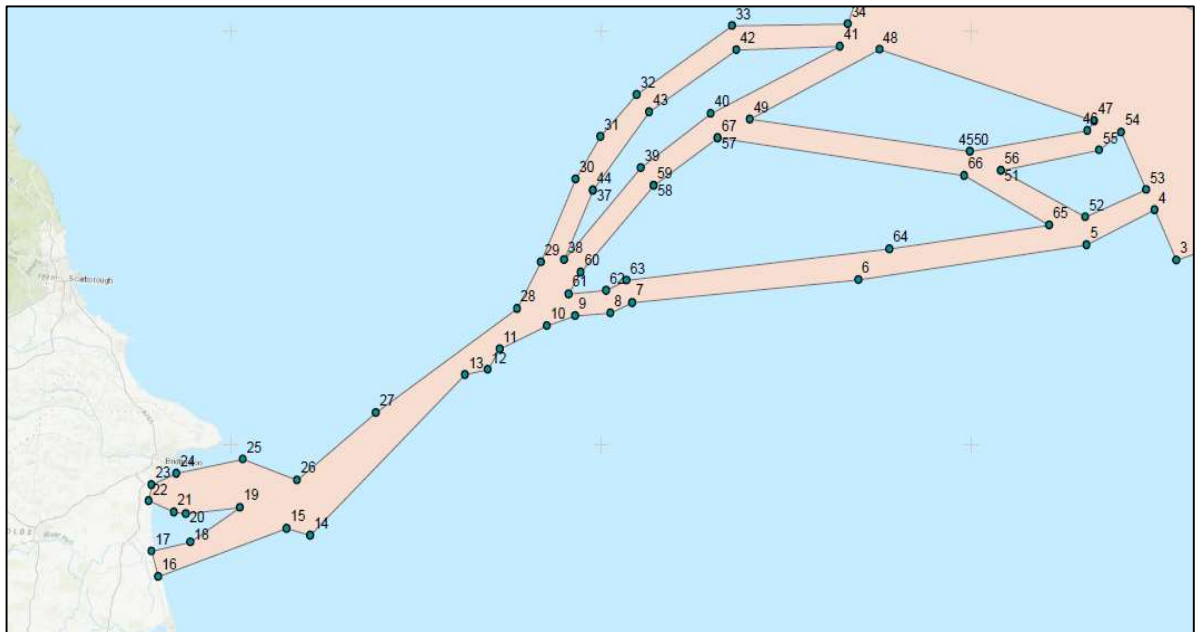


Figure 2.2 Maximum extent of survey operations (Export Cable Route Options)

3. Offshore Geophysical Investigation

The geophysical survey operations on the Dogger Bank South array sites continue with the Fugro Frontier until approximately the 31st October 2022.

The Fugro Searcher is expected to join the same area from the 7th July until the 15th August 2022.

The geophysical survey operations on the Export Cable Routes are expected to be carried out with the following vessels:

Fugro Discovery from the 9th June to the 20th July 2022

Valkyrie from the 13th June to the 20th July 2022 (Nearshore to 15m water depth)

Please note that the exact start and finish date will be dependent on the prevailing weather conditions and work progress.

Important Information


As the Fugro Frontier and Fugro Searcher will be towing survey equipment. The vessels will require large turning circles and will be restricted in her ability to manoeuvre. All vessels operating within the array area are requested to keep their distance, maintaining at least the 1,000m safety zone around the survey vessel, and pass at minimum speed to reduce vessel wash.

The Fugro Discovery and Valkyrie operating on the export cable routes will be towing survey equipment and request that passing vessels maintain a 500m safety zone around the survey vessel.

A continuous listening watch will be conducted on VHF Channel 16 by all survey vessels.

Survey operations will be conducted on a 24-hour basis.
