1 Introduction

Mariners are advised that Orsted Hornsea Project Three (UK) Limited (hereafter 'Orsted') will be commencing a scope of Geotechnical survey works from the 31st of May 2022. The survey is being undertaken for the purposes of geotechnical investigations of the Hornsea Project Three Offshore Wind Farm (Hornsea Three) project, located within the UK Sector of the North Sea, off the coast of East Yorkshire.

2 Area of operations

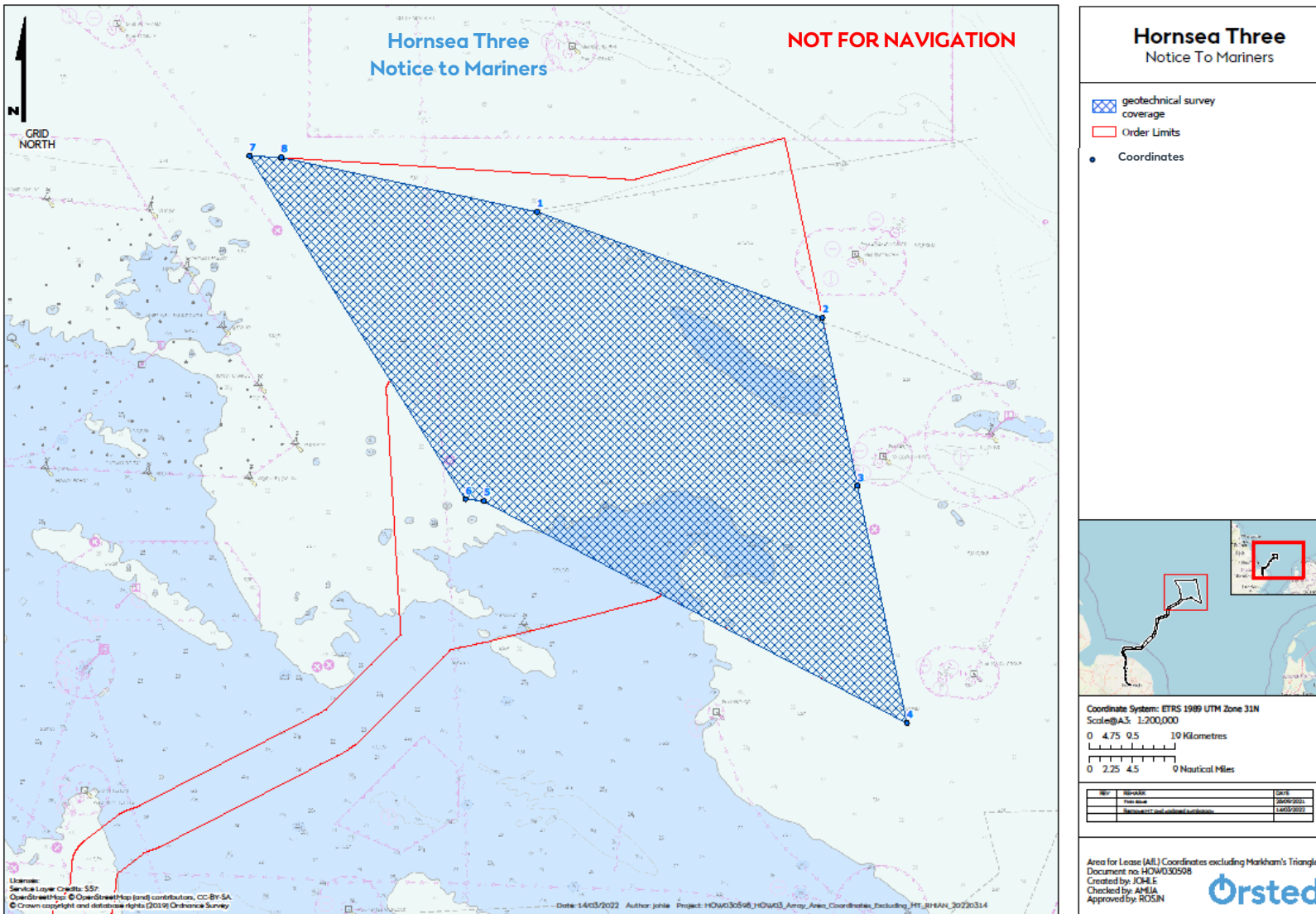


Figure 1: Hornsea Three Survey Coverage

Activities are being carried out within the Hornsea Three Order Limits, and the extent of the area in which the survey will be conducted is shown in Figure 1.

3 Proposed activities

3.1 Proposed survey activity

Please be advised that the operations are anticipated to mobilise from the 31st of May 2022 with investigations targeting the site. The works will last for approximately 7 days. The exact survey dates are dependent on mobilisation time, weather and work progress.

Note that the vessels will have limited manoeuvrability and it is requested that all vessels operating near the survey vessels maintain a safe distance (at least 500m) and pass at minimum speed.

3.2 Safety

It is requested that anybody having knowledge of any potential objects submerged or moored on the seabed within the survey area that could be damaged or form a hazard to the survey vessel and its equipment advises Hornsea Three's Onshore Fisheries Liaison of their position and nature.
