Notice of Construction Work Commencement

1 Introduction

Mariners are advised that Orsted Hornsea Project Three (UK) Limited (hereafter 'Orsted') will be commencing construction work from 4th February 2023 and is expected to be fully complete by 30th June 2023 at the site listed below:

Lowestoft

The work is being undertaken for the purpose of constructing two kittiwake artificial nesting structures as part of a compensation scheme associated with the Hornsea Project Three Offshore Wind Farm (Hornsea Three) project, located within the UK Sector of the North Sea.

2 Area of operations




Figure 1: Hornsea Three Constuction Coverage – Lowestoft ANS2






Figure 2 - Hornsea Three Constuction Coverage — Lowestoft ANS3

The works will take place within the boundaries illustrated in Figure 1 and Figure 2.

3 Proposed activities

3.1 Proposed construction activity

The work will comprise the construction of two artificial nesting structures (ANS) for kittiwake, which will be situated approximately 1km off the coast of South Beach, Lowestoft, East Suffolk (coordinates listed in **Section 8**).

Construction will be limited to 48 days of construction activity between February 2023 and June 2023. Please be advised that construction is anticipated to start on 4th February 2023 and work will be fully complete by 30th June 2023. The exact construction dates are dependent on mobilisation time, weather and work progress.

At present, foundation has been installed at ANS 2 and lit in accordance with lighting and marking plan (flashing yellow 3 nautical mile range); construction activities ongoing.

3.2 Safety

Note that the construction vessels will have limited manoeuvrability and it is requested that all vessels operating near the construction vessels maintain a safe distance (at least 500m) and pass at minimum speed.

It is requested that anybody having knowledge of any potential objects submerged or moored on the seabed within the construction area that could be damaged or form a hazard to the construction vessels and their equipment advises Hornsea Three's Offshore Fisheries Liaison of their position and nature.
