### **Description of Hazard/Operation**

The offshore survey vessel **Mimer** will carry out a multibeam echo sounder (MBES) survey prior to wind turbine generator (WTG) installation operations at Dogger Bank A. The MBES equipment will be hull mounted with no towed equipment involved in the operations.

The works will commence on the 15<sup>th</sup> of May 2023, continuing until 15<sup>th</sup> June when all WTG locations will have been surveyed. The works will be continuous, 24 hours a day. A chart of the DBA construction area and bounding coordinates is provided below.

During operations, the **Mimer** will be restricted in its ability to manoeuvre as defined under COLREGs (International Regulations for Preventing Collisions at Sea 1972) and will display the appropriate day shapes and lights. The vessel will also transmit an Automatic Identification System (AIS) message.

It is requested that all vessels maintain a minimum of 500m separation distance from the **Mimer** and pass at reduced speed.




Figure 1: Dogger Bank A OWF Array Area and WTG Layout
