1 Introduction

Mariners are advised that Orsted Hornsea Project Three (UK) Limited (hereafter 'Orsted') are attending site to perform routine maintenance at:

- ANS2, Lowestoft.
- ANS3, Lowestoft

The maintenance will be undertaken on the kittiwake artificial nesting structure which was constructed as part of a compensation scheme associated with the Hornsea Project Three Offshore Wind Farm (Hornsea Three) project, located within the UK Sector of the North Sea.

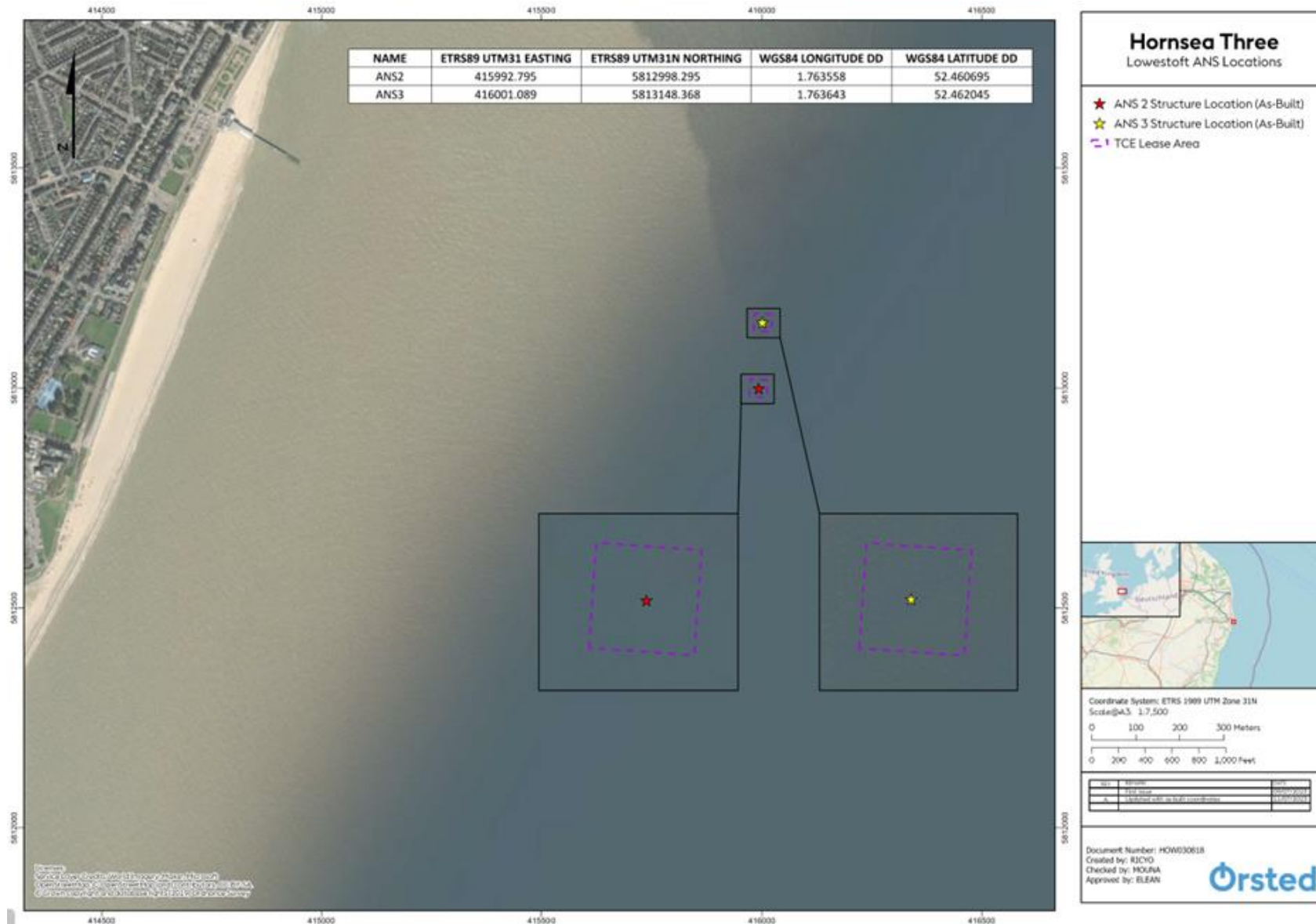


Figure 1: Hornsea Three Work Area – Lowestoft ANS2 and ANS3

The works will take place within the boundaries illustrated in [Figure 1](#), coordinates are detailed in [Section 7](#).

3.1 Proposed activity

Hornsea Three are undertaking annual maintenance of the ANS structure in accordance with Marine Licence L/2022/009523/1.

This proposed activity will be following the below schedule and the vessel details are outlined in the **Section 6**. The notice will be updated accordingly should there be a change to the proposed activity or on completion of works.
