## **1 Introduction**

Mariners are advised that Orsted Hornsea Project Three (UK) Limited (hereafter 'Orsted') are attending site to perform routine maintenance at:

- ANS1 Minsmere

The maintenance will be undertaken on the kittiwake artificial nesting structure which was constructed as part of a compensation scheme associated with the Hornsea Project Three Offshore Wind Farm (Hornsea Three) project, located within the UK Sector of the North Sea.

## **2 Area of operations**

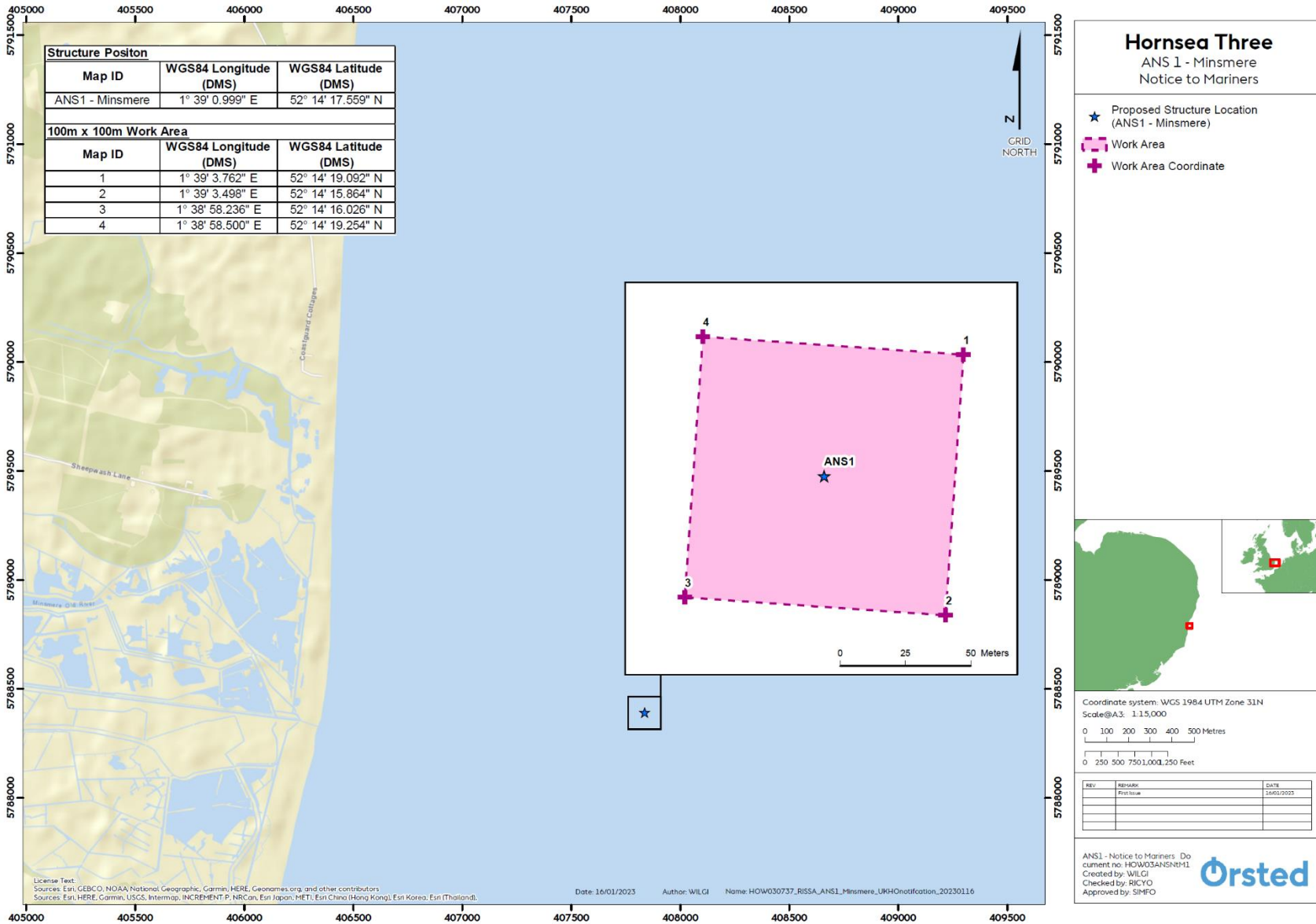


Figure 1: Hornsea Three Work Area – Minsmere ANS1

The works will take place within the boundaries illustrated in **Figure 1**, coordinates are detailed in **Section 7**.

#### 3.1 Proposed activity

Hornsea Three are undertaking annual maintenance of the ANS structure in accordance with Marine Licence L/2022/00543/1.
