Description of Hazard/Operation

The Offshore Supply Vessel, **CONNECTOR** will be carrying out a short geotechnical survey within Dogger Bank D (**DBD**) Array Area and Export Cable Route.

The works will be performed in a single campaign, commencing on the 28th of June 2025, continuing until 12th July when all locations will have been surveyed. The works will be continuous, 24 hours a day. A chart of the **DBD** Array Area + Export Cable Route and table of bounding coordinates is provided below.

During operations, the **CONNECTOR** will be restricted in its ability to manoeuvre as defined under COLREGs (International Regulations for Preventing Collisions at Sea 1972) and will display the appropriate day shapes and lights. The vessel will also transmit an Automatic Identification System (AIS) message.

It is requested that all vessels maintain a minimum of 500m separation distance from the **CONNECTOR** and pass at reduced speed.

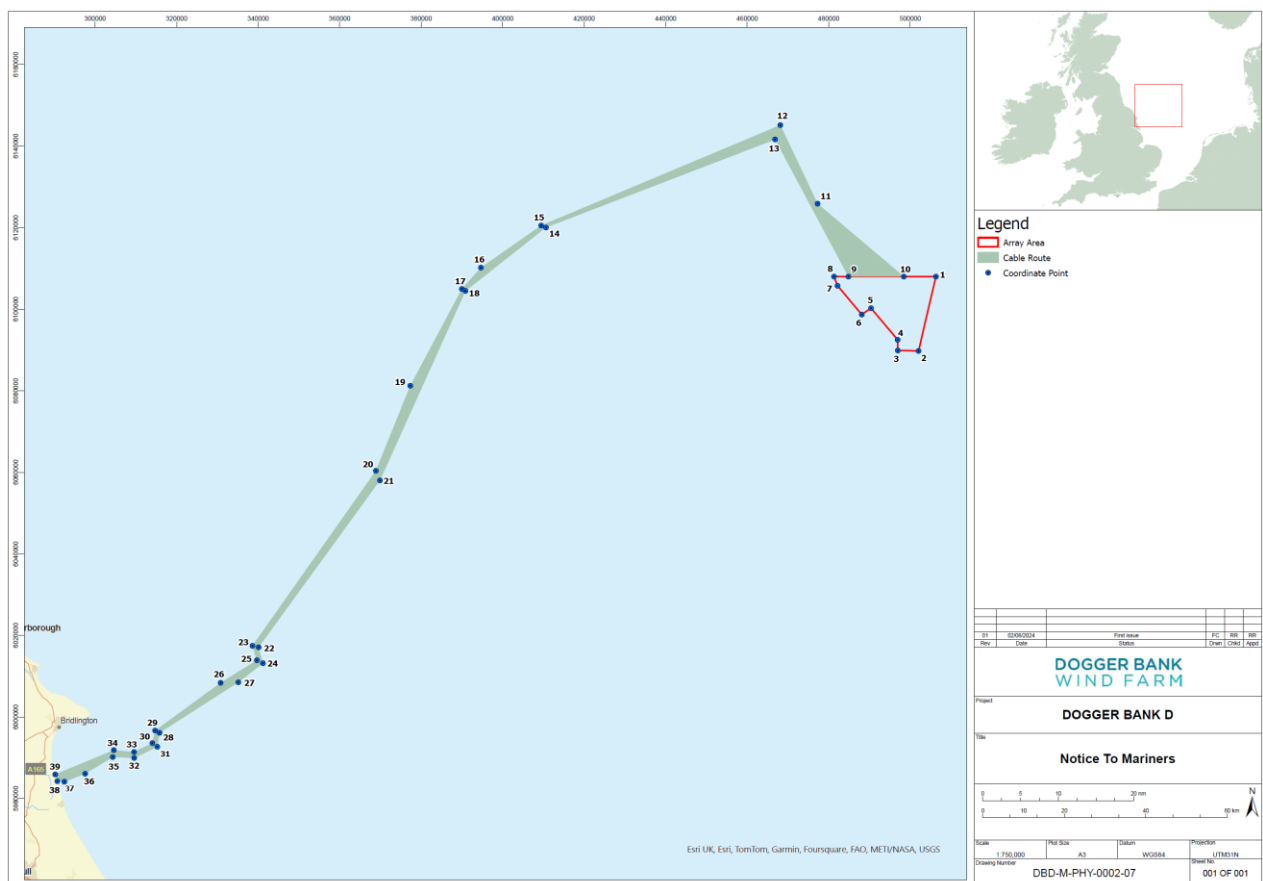


Figure 1: Dogger Bank D Array Area and Potential Export Cable Routes
