MARINE ACTIVITIES

1.1. Summary:

Mariners are advised that the vessels 'NKT Victoria' and 'Haltbakk Star' will be involved in ship-to-ship fuel transfer operations within the East Anglia THREE export cable corridor, the expected location of the operation is in the proximity of KP90 as detailed in section <u>2.1</u> of this document.

All marine traffic is advised to maintain a 500m safety zone around NKT Victoria and Haltbakk Star during fuel transfer operations and pass at a reduced speed.

1.2. Activity Description:

Haltbakk Star and NKT Victoria will be engaged in fuel transfer operations whilst moored alongside each other. During this time, both vessels will have restricted maneuverability as defined under COLREGs (International Regulations for Preventing Collisions At Sea 1972) and will display appropriate day shapes and lights as well as transmitting an Automatic Identification System (AIS) message.

Haltbakk Star and NKT Victoria will monitor VHF Channel 16 and VHF DSC Channel 70 continuously the bunkering operation.

1.3. Program Schedule:

The ship-to-ship fuel transfer operations are scheduled to commence circa the 07th October 2025, weather dependant. Completion of works will be notified via cancellation of this Notice to Mariners.


