NOTICE TO MARINERS – 27/10/2025

Planned Activity

All Mariners are advised that and MV Survey Vessel *VOS Gorgeous* (Call-Sign 2HEN8) and vessel *Ocean Marlin* (Call Sign 2CQX3) will be performing a program of survey and investigation works off the coast of East Anglia operated by Sulmara Subsea Limited on behalf of their client, Scottish Power Renewables.

The survey work consists of three (3) different phases, as follows:

- Phase 1 – (*VOS Gorgeous*) Offshore survey comprising a towed array of hydrographic survey equipment approximately 200 m in length within the boundary highlighted in Figure 1 and coordinates in Table 2. This phase is expected to last up to four weeks.
- Phase 2 – (*VOS Gorgeous*) Environmental Survey within the General Area boundary coordinates (Table 2) comprising various stationary elements. This follows from Phase 1 and is expected to last approximately 3 days.
- Phase 3 – (*Ocean Marlin*) – ROV survey within the same boundary coordinates as in Phase 1 and 2. This phase will start simultaneously and is expected to last approximately 30 days.

Both offshore vessels will operate 24 hours per day.

The exact start and finish dates will be dependent on the prevailing weather conditions and work progress but the above represents current best estimates.

During acquisition, both vessels will be restricted in changes to course and speed, or stationary with restricted movement. It is requested that all vessels maintain a safe distance and not pass within 500 metres of the vessel.

Throughout these operations, both vessels will be displaying the shapes and lights prescribed in the International Rules for the Prevention of Collisions at Sea (COLREGS) Rule 27, (Vessels restricted in their ability to manoeuvre).

Figure 1: Schematic of intended survey activity including Phase 1, 2 and 3 working area with 1.5 km buffer

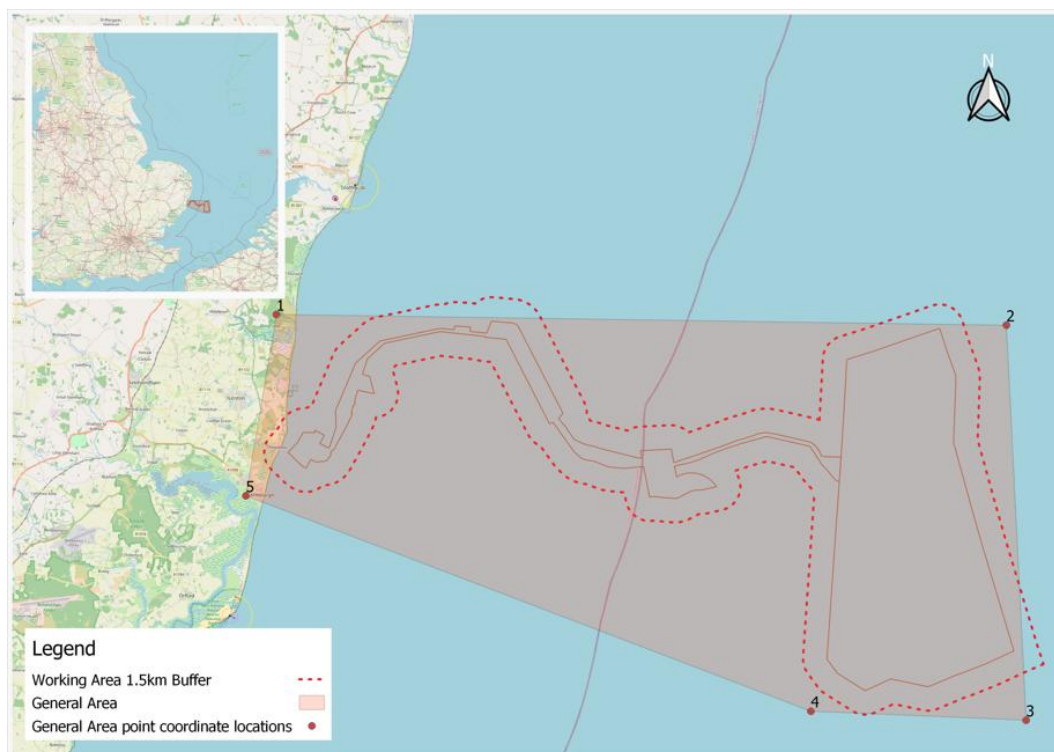


Figure 2: Schematic of intended working area for the activity showing corner coordinates for ease of navigation and planning.
