## Lincolnshire/Norfolk coastlines - Anglian Water

## Introduction

As part of its Water Resource Management Plan for the period 2025 to 2050 (WRMP24), Anglian Water Services has investigated and developed alternative water supply options which include the abstraction and desalination of seawater. In service of this effort, Atkins-Realis, on behalf of Anglian Water, is coordinating seawater sampling surveys off the Lincolnshire and Norfolk coastlines, commencing on 13/10/2025. This is the third of four sampling campaigns scheduled to take place in 2025/2026.




Figure 2: Survey Area at Mablethorpe. Sites M1 and M2.

**Each campaign will last approximately 20 days**, divided equally between the two locations indicated by the charts (**Figures 1 and 2**) and coordinates below (**Table 1**).

The vessel details and contact information can be found in Tables 2 and 3.

Mariners are advised the vessel "AMS SPIRIT" will be carrying out this work off Norfolk at Bacton, and off Lincolnshire at Mablethorpe. Two sampling sites will be located approximately 750m off the coast at Bacton, (B1 and B2). There are two sampling sites located at Mablethorpe, one approximately 4km off the coast (M1) and one approximately 6km off the coast (M2).

Vessels are requested to maintain a safe distance of 500m as underwater scientific equipment will be deployed during the campaign and the survey vessel will have restricted manoeuvrability.


